

Assembly Bill 2260 “Healthy Schools Act of 2000” – Annual Notification of Planned Pesticide Use

To: Parents and/or Guardians and CUHS Employees

From: Director of Maintenance and Operations, Corning U.H.S.D.

The Healthy Schools Act of 2000 requires schools to provide parents and/or guardians of students and school staff with annual written notification of pesticides use. During the school year, it may be necessary to apply pesticides at your child’s school to avoid serious health problems posed by pests or to maintain the integrity of the school buildings and grounds.

The Act also provides parents and/or guardians and school employees the opportunity to register with the school district if they wish to be notified of individual pesticide applications at their specific school site. Persons who register for this notification will be notified at least 72 hours prior to any application.

It is the intent of the Corning Union High School District to minimize the use of chemical pesticides and, when their use cannot be avoided, to utilize the least toxic appropriate method.
